

# Indian Creek "End of the Season" Finale Meet

- PHILOSOPHY:** This meet was developed for those athletes that have not achieved any championship cuts and have nothing after mid-July. Wanting to keep these athletes in the water longer, we created this meet. To make this meet different and exciting, we will be moving the pool back to **yards** and running a HS event order - this way the swimmers can see how their summer work has paid off in their "school events". There will be no ribbon awards; however, ICAC will supply each athlete with a post meet pizza party.
- We would like to keep this meet at the 13&Over level. However, if you have any younger athletes that would benefit from a meet like this, then please encourage them to attend. We hope that you find this meet as a great way to conclude your long course season for some of your athletes and look forward to seeing you here.
- SANCTION:** This meet is sanctioned by USA Swimming and Indiana Swimming. Sanction number #IN11363
- LOCATION:** Indian Creek Natatorium

- FACILITY:** The Indian Creek Natatorium will be configured to an 8-lane, 25 yard course. This meet will be swam in a 25 yard, 8 lane course with 6 additional 20 yard lanes for continuous warm-up/cool down. Pool depth at starting end is 5' 0" and 5' 8" at the turning end. The competition course has not been certified in accordance with 104.2.2C(4). Daktronics timing system and touchpads will be used with an 8-lane readout scoreboard.
- ELIGIBILITY:** Swimmers must be registered with USA Swimming to be accepted into this meet. Age as of July 26, 2011, will determine the swimmer's age for the meet.
- RULES:** Current USA Swimming and Indiana Swimming rule will govern this meet. Coaches **MUST** constantly display their USA Swimming coach credentials to gain deck access. The meet referee reserves the right to ask for coaches to display their credentials and/or deny deck access if a coach does not comply. USA Swimming rule 202.3.2 states that a sanction competitive event, USA Swimming athletes members must be under the supervision of a USA Swimming coach during warm-up, competition, and warm-down. The Meet Director or Meet Referee shall assist the athlete in arranging for such supervision. Any swimmer entered in the meet, unaccompanied by a USA Swimming member coach, must be certified by an USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

RULES (con't): In swimming competitions, the competitor must wear only one swimsuit in one or two pieces except as provided in USA Swimming Rule 205.10.1. All swimsuits shall be made from textile materials. For men, the swimsuit shall not extend past the navel nor below the knees, and for women, shall not cover the neck, extend past the shoulder, nor extend past the knee.

FORMAT: This meet will be run on a timed final format in SCY. This meet is design to allow our older swimmers a chance to swim at the end of the season. We prefer to keep this at the 13&Over level, but if you do have some younger athletes that would benefit from this meet – you are definitely encouraged to bring them. We are running this even in SCY yards to allow the swimmers to gauge their season progress in times they are typically more familiar.

ENTRIES: Swimmers are limited to three (3) events plus two (2) relays.

Entries may be submitted by email or in writing. Entry deadline is Tuesday, July 12, 2011. Deadline will be extended if meet is not full. If submitting entries on computer disk or in writing, your entry fees and the signed release form should be sent with the entry. Teams that email entry must pay fees and submit signed release form by the start of the meet. A complete list of USA swimming registration numbers for all swimmers in the meet must be included with your entry.

FEES: Entry fee is \$3.50 per individual event and \$5.00 per relay event as well as the \$1.50 Indiana Swimming surcharge per swimmer. Make checks payable to Indian Creek Aquatic Club. Deck entries will be \$5.00 per individual event and \$8 per relay event. Any entries after the entry deadline will be considered on deck and will be charged accordingly. If for any reason any events are limited, ICAC will refund the entry fees to the club(s) whose swimmers are not allowed to compete in the limited events.

CHECK-IN: ALL SWIMMERS MUST CHECK-IN PRIOR TO WARM-UPS. Check-in sheets will be taken down 20 minutes after the start of warm-ups. Swimmer who fail to check-in will be scratched.

FINAL RESULTS: One copy will be provided to every participating club.

PSYCH SHEETS: Pysch sheets will be available for \$1.00. No admission charge.
