

## **GREENWOOD FALL FRENZY**

**Greenwood, Indiana**

**November 11 & 12, 2011**

- SANCTION:** This meet is sanctioned by USA Swimming and Indiana Swimming. Sanction number IN 12092.
- LOCATION:** Greenwood Community High School, 615 Smith Valley Road, Greenwood, Indiana 46142
- FACILITY:** The meet will be held in the Greenwood Community High School Natatorium. Our pool is a 25-yard pool with 6 lanes, starting blocks, and non-turbulent lane dividers, and Colorado electronic timing system, utilizing stopwatch back-up times. HY-TEK Meet Manager will be used to run the meet.
- Water depth: 4.5' at the start end and 5.5' at the turn end.  
The competition course has not been certified in accordance with 104.2.2C(4).  
Spacious deck and bleacher seating is available for participants and spectators.
- ELIGIBILITY:** Swimmers must be registered with USA Swimming to be accepted into this meet. Age as of November 11, 2011 shall determine the swimmer's age for the entire meet.
- \*\*\*Indiana Swimming does not process on-site athlete registration.
- RULES:** Current USA Swimming and Indiana Swimming rules will govern this meet. USA Swimming Rule 202.3.2 – At a sanctioned competitive event, USA Swimming athlete members must be under the supervision of a USA Swimming member coach during warm-up, competition, and warm-down. The Meet Director or Meet Referee shall assist the athlete in making arrangements for such supervision.
- Any swimmer entered in the meet, unaccompanied by a USA Swimming member coach, must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.
- Coaches **MUST** constantly display their current USA Swimming coach credential to gain deck access. The meet referee reserves the right to ask for coach credential display and/or deny deck access if coach does not comply or card is no longer valid/current.
- In swimming competitions, the competitor must wear only one swimsuit in one or two pieces except as provided in 205.10.1. All swimsuits shall be made from textile materials. For men, the swimsuit shall not extend above the navel nor below the knees, and for women, shall not cover the neck, extend past the shoulder, nor extend below the knee.

**FORMAT:** All events will be timed finals, enter in yard times. Greenwood Gators reserves the right to limit entries in any event in order to adhere to the 4-hour rule for age group swimmers. Fastest seed times will be the determining factor, with the exception of Greenwood Gators swimmers who will be allowed to swim regardless of entry time. The number of heats will be determined after receipt of all entries and after reviewing the time line. Clubs with swimmers not accepted will be notified. Refunds will be made to all clubs with swimmers not allowed to compete in the limited events. Individual swimmers must provide own counter and timer for the 1650 Free. Individual swimmers must provide own counter for 500 Free events.

**ENTRIES:** Swimmers are limited to five (5) individual events and one relay event per day.

**DEADLINE:** Entries will be accepted starting October 4, 2011. **Entry deadline is October 28, 2011. Teams that we are not able to accept will receive notification within 72 hours of the entry deadline.** The entry deadline will be extended if the meet is not full.

**FEES:** Entry fees for this meet are \$4.00 per individual event and \$6.00 per relay. An Indiana Swimming Athlete Surcharge of \$1.50 also applies to each swimmer.

Fees for on deck entries are \$8.00 per individual event and \$12.00 per relay event.

**IF A SWIMMER SCRATCHES AN EVENT OR THE ENTIRE MEET, WE CANNOT SUBSTITUTE ANOTHER SWIMMER IN HIS/HER PLACE. A REPLACEMENT SWIMMER IS CONSIDERED TO BE A NEW ENTRY AND WILL BE CHARGED ACCORDINGLY.**

**CHECK-IN:** **ALL SWIMMERS MUST CHECK IN PRIOR TO WARMUPS.** Check in sheets will be taken down **15 minutes** after warm-ups begin. Swimmers who fail to check in will be scratched.

**CLERK OF COURSE:** A clerk of course will be conducted for 8 & under swimmers only. 8 & under swimmers must report to the clerk when called. All other swimmers will report directly to the blocks.

**AWARDS:** Awards for places 1-12. Relays 1-6.

To eliminate confusion, we ask that "coaches only" pick up awards at the end of the day. 6&U and 7-8 will swim together and 13-14 and 15&O will swim together, but awards will be separate in each age group.

High point Trophy for each Boys and Girls age division of 8 & U, 9 -10, 11-12, 13-14, and 15&O.

**SCORING:** Scoring for individual events will be 7-5-4-3-2-1.  
Winners of trophies will be determined by the total number of points accumulated in individual events.

**PSYCH SHEETS:** Psych sheets will be available for purchase at the natatorium entrance.

Meet begins: 5:30 PM

**Saturday AM Session**  
Warm-up begins: 7:00 a.m.  
Meet begins: 8:15 a.m.

**Saturday PM Session**  
Warm-up begins: Immediately following the end of the morning session, but not before 12:00 noon.  
Meet begins: Meet will begin one hour after warm-ups begin, but not before 1:15 p.m.

**ADDITIONAL FACILITY INFORMATION:** Refreshments will be provided throughout the meet. A hospitality room will be available for coaches and officials. A camping area will also be available. We ask that you cooperate in keeping your swimmers under control and in cleaning up your camping area following each meet session. Parking is available in the parking lot east of the building. Please enter school at entrance 31E.

**COACHES:** A complimentary heat sheet will be provided to each team coach at check-in. One copy of the final results will be made available to each team. Coaches are welcome to bring flash drives to download final results at the end of the meet. A Coaches' Meeting will be held in the hospitality room at 8:10 AM on Saturday.
