SANCTION: This meet is sanctioned by USA Swimming and Indiana Swimming. Sanction number: IN12138

LOCATION: Indian Creek Natatorium
Indian Creek High School
803 W. Indian Creek Drive
Trafalgar, IN 46181

FACILITY: The Indian Creek Natatorium has a 25 yard, 8 lane pool with 6 additional 20 yard lanes for continuous warm-up/cool down. Water depth is 5'0" at the starting end and 5'6" at the turn end. The competition course has not been certified in accordance with 104.2.2C(4). Daktronics timing system and touchpads will be used with an 8-lane readout scoreboard.

ELIGIBILITY: Swimmers must be registered with USA Swimming to be accepted into this meet. Age as of January 6, 2012, will determine the swimmer's age for the entire meet.

RULES: Current USA Swimming and Indiana Swimming rule will govern this meet. USA Swimming rule 202.3.2 states that a sanction competitive event, USA Swimming athletes members must be under the supervision of a USA Swimming coach during warm-up, competition, and warm-down. The Meet Director or Meet Referee shall assist the athlete in arranging for such supervision.

Any swimmer entered in the meet, unaccompanied by a USA Swimming member coach, must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

Coaches **MUST** constantly display their USA Swimming coach credentials to gain deck access. The meet referee reserves the right to ask coaches to display their credentials and/or deny deck access if a coach does not comply.

In swimming competitions, the competitor must wear only one swimsuit in one or two pieces except as provided in USA Swimming Rule 205.10.1. All swimsuits shall be made from textile materials. For men, the swimsuit shall not extend above the navel nor below the knee, and for women, shall not cover the neck, extend past the shoulder, nor extend below the knee.

Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms, or locker rooms.

- FORMAT:** All events will be TIMED FINALS. ICAC reserves the right to limit entries in any event in order to adhere to the 4-hour rule for age-group swimming. Fastest seeded times will be the determining factor. The number of heats will be determined after receipt of all entries and reviewing the timeline. REFUNDS WILL BE MADE IF ENTRIES ARE LIMITED.
- This meet is design to promote the aerobic base of our age-group swimmers, providing opportunities for HS swimmers to obtain cuts in events that are not offered in the high school setting, to promote IM swimming, and most importantly, to encourage the fun of the sport. Keeping the last two objectives in mind, we will be combining the times for the 50 Free, 50 Breaststroke, 50 Backstroke, 50 Butterfly, and the 200 IM (25s of strokes and 100 IM for 8&Unders) to come up with a composite IM time for a "pentathlon" award in each age-group. This applies to the 13&Over swimmers on Friday evening and the 12&Under swimmers on Saturday. Swimmers will need to participate in all 5 of the listed events to be considered for the "pentathlon" awards.
- ENTRIES:** Swimmers are limited to five (5) events per day.
- Entries may be submitted by email, on computer disk, or in writing. Entry fees and the signed release form must be received by the start of the meet on Friday, January 6, 2012. Teams who fees have not been received by the deadline will not be allowed to compete. A complete list of USA swimming registration numbers for all swimmers in the meet must be included with your entry.
- DEADLINE:** Entries will be accepted starting December 9, 2011, at 8am. Entry deadline will be December 23, 2011. We will extend the deadline if the meet is not full.
- FEES:** Entry fee is \$4.00 per event plus a \$1.50 Indiana Swimming surcharge per swimmer. Make checks payable to Indian Creek Aquatic Club. In the event that entries have to be limited, ICAC will return the entry fees to the clubs whose swimmers are not allowed to compete in the specific limited events.
- Fees for deck entries will be \$8.00 per event. Entries after December 23, 2011, will be considered on deck and charged accordingly.
- CHECK-IN:** ALL SWIMMERS MUST CHECK-IN BEFORE WARM-UPS. Check-in sheets will be taken down 20 minutes after the start of warm-ups. Swimmers who fail to check-in will be scratched.
- CLERK OF COURSE:** This will be a card-less meet. 8 & Unders will be clerked and escorted to blocks.
- AWARDS:** Ribbons for 1-16 place will be awarded for each individual event. Special awards will be given to the top eight finishers in the IM pentathlon for boys and girls in each of the following age-groups: 8&Under, 9-10, 11-12, 13-14, 15&Over.
- FINAL RESULTS:** Electronic result files will be provided to every participating club.

HEAT SHEETS: Heat sheet will be available for \$2.00. No admission charge.
