Key Items:

- 1. Deadline for submission of any legislative or Bylaw proposals is August 1st preceding HOD. Proposals received by the submission date have the following requirement for pass at HOD: Bylaw updates, require a 2/3 membership vote to pass and technical legislation, require a simple majority.
- 2. In keeping with Roberts Rules of Order, any submission not going to the floor for any reason, including late submission, may be brought to the floor of the House of Delegates, but must pass with a 90% vote.
- 3. Motions should generally be stated in the affirmative.
- 4. If you wish to speak, please move to an available microphone. Once recognized by the Chair, please identify yourself by name and club.
- 5. When a badge count is used, please raise your hand high and keep it still until the count is complete. During a badge count, please do not move from your original position.
- 6. A main motion may only have two amendments pending at any one time.
